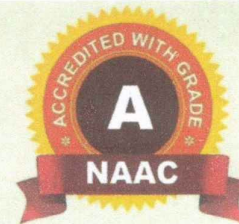

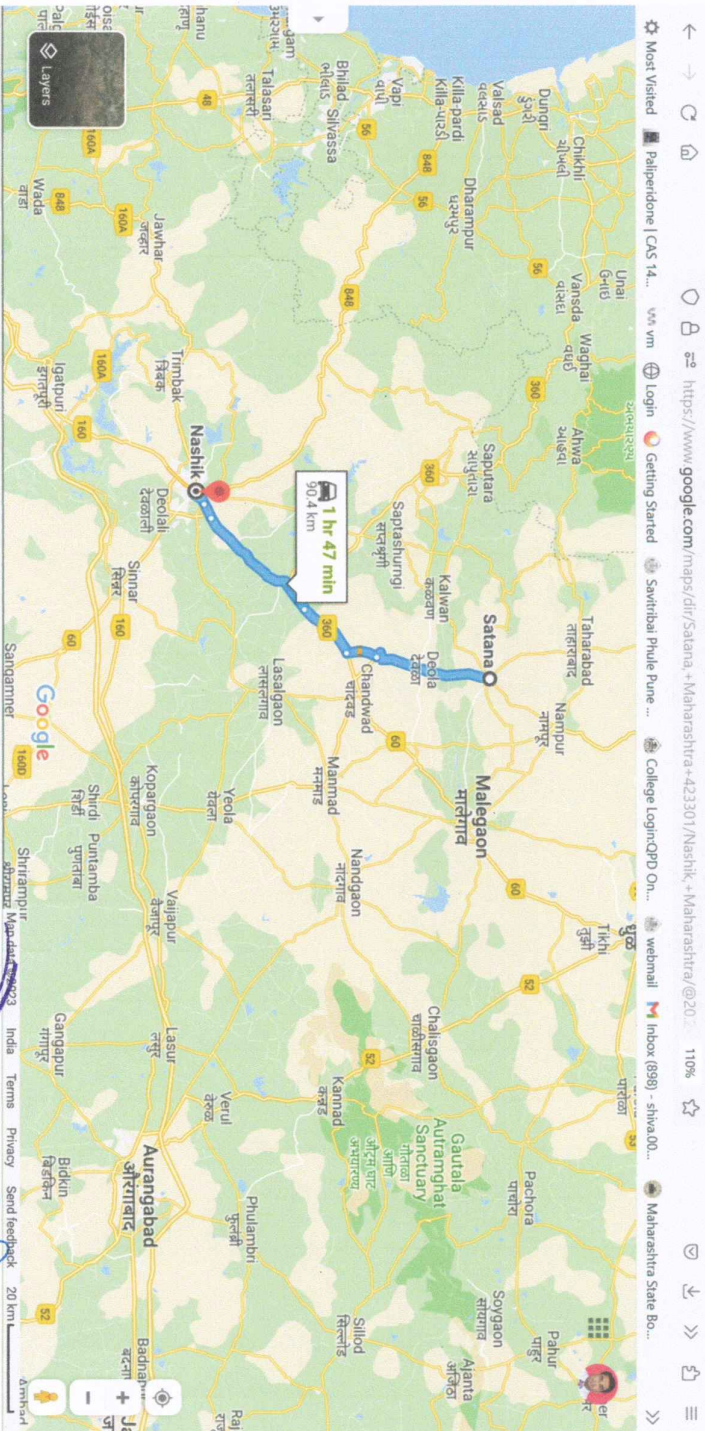

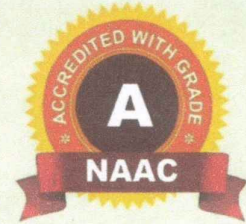

**Baglan Taluka Population - Nashik, Maharashtra**

Baglan is a Taluka located in Nashik district of Maharashtra. It is one of 15 Talukas of Nashik district. There are 170 villages and 1 towns in Baglan Taluka.

As per the Census India 2011, Baglan Taluka has 73372 households, population of 374435 of which 193072 are males and 181363 are females. The population of children between age 0-6 is 52330 which is 13.98% of total population.

The sex-ratio of Baglan Taluka is around 939 compared to 929 which is average of Maharashtra state. The literacy rate of Baglan Taluka is 66.62% out of which 71.41% males are literate and 61.53% females are literate. The total area of Baglan is 1453.40 sq.km with population density of 258 per sq.km.

Out of total population, 89.93% of population lives in Urban area and 10.07% lives in Rural area. There are 5.07% Scheduled Caste (SC) and 40.02% Scheduled Tribe (ST) of total population in Baglan Taluka.

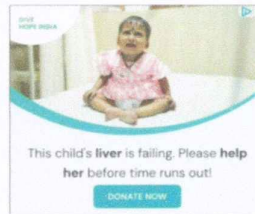

**Map of Baglan, Nashik, Maharashtra**

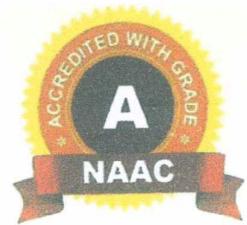
